

Application by an Alien or a British Protected Person for a Certificate of Naturalization

under section 9 of the Mauritius Citizenship Act, 1968

The instruction accompanying this form must be read carefully before the form is completed. Portions of the form which are not applicable should be struck out and initialed in every case.

Caution : Subsection (1) of section 20 of the Mauritius Citizenship Act, 1968 provides that:-

“Any person who for the purpose of procuring anything to be done or not to be done under this Act or under Regulations made under this Act makes any statement which he knows to be false in a material particular, or recklessly makes any statement which is false in a material particular, shall be liable on conviction to imprisonment for a term not exceeding one year or to a fine not exceeding one thousand rupees.”

Section 195 of the Courts Ordinance, 1945, provides that:-

“Any person swearing a false affidavit whenever an affidavit is required or may be used, shall be liable to penal servitude not exceeding three years and to a fine not exceeding one thousand rupees.”
